Subject: Update Unified Development Ordinance

Background: In May 2020, the City retained the firm of Kendig Keast Collaborative (KKC) to prepare the City's Unified Development Plan. KKC has completed the first task of the project which included, but was not limited to, Project Orientation, Stakeholder Meetings, and existing Ordinance Critique. A presentation was provided to staff regarding the results of the Ordinance Critique. Additionally, an Annotated Outline was also reviewed with staff indicating the organizational hierarchy for the UDO in a table format with each proposed section and existing ordinance sections consolidated in the new format. This work forms the basis of the work for Task 2. Prior to beginning Task 2, KKC will present an update on the current progress and status of the UDO and provide a short overview of Task 2 deliverables.
